



Valparaiso University Professional Licensure and Certification Disclosure

Federal regulations require VALPARAISO UNIVERSITY to publicly disclose, for each educational program designed to meet the educational requirements for a specific professional license or certification required for employment in an occupation (or advertised as meeting those requirements), information about whether program completion would meet those requirements in a state. These public disclosure requirements apply to all programs, regardless of their modality.

Valparaiso University participates in the National Council for State Authorization Reciprocity Agreements (NC-SARA) to offer distance education programs. NC-SARA requires the university to meet all disclosure requirements for all courses or programs designed to meet professional licensure or certification.

The information below should not be construed as guaranteeing that any particular professional licensure/certification authority will approve a student's application; nor should the information below be read to imply that other requirements for professional licensure/certification do not exist or that other requirements for professional licensure/certification have been determined to have been met by Valpo's program/course, or that any necessary approvals for clinical or other experiential learning placements are secured by virtue of a student's enrollment at the university.

State professional licensure/certification requirements are subject to change at any time.

The tables below provide information on Valparaiso University's determination if a program meets the educational requirements for licensure in a state, commonwealth or US territory. There are often additional requirements (residency, experience, examinations, etc.) required by a state/territory.

A distance education student wishing to enroll in a professional licensure program but whose location at the time of initial enrollment is in a state where the program does not meet the state's educational requirements for licensure cannot be enrolled in that program. However, the student can attest to seek employment in a state where the program meets the state's educational requirements and may then be enrolled.

The following statement should be used and is required by ACOTE during our candidacy status: The entry-level occupational therapy doctoral degree program has applied for accreditation and has been granted Candidacy Status by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 7501 Wisconsin Avenue, Suite 510E, Bethesda, MD 20814. ACOTE's telephone number c/o AOTA is (301) 652-AOTA and its web address is www.acoteonline.org. The program must have a preaccreditation review, complete an on-site evaluation, and be granted Accreditation Status before its graduates will be eligible to sit for the national certification examination for the occupational therapist administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be an Occupational Therapist, Registered (OTR). In addition, all states require licensure to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. A felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.
