4. Prepare Problems 1 and 2 on p. 77 of the text. In Problem 1, assume in each case that the decedent's estate totals \$600,000. To complete Problem 1, you need not refer to the estate planning problem on pp. 49-50 of the text. You only need to know that Howard and Wendy have two daughters, Sarah and Stephanie, and that Wendy has one son, Michael, from a previous marriage. Focus on the parts of the problems that require you to determine the heirs' shares under the Uniform Probate Code (UPC).
