Advanced Legal Research

A second year required elective course, also open to third year students. This course is designed to teach students the process of legal research, going beyond what is taught in the first year course. The course covers an in-depth look at print sources, online sources and a wide variety of secondary sources. Students are required to work a number of problems, concentrating on the process of creating research issue statements, examining secondary sources, finding appropriate primary sources (statutes, regulations and cases) at both the state and federal levels, updating and verifying the primary sources found, and writing brief memos giving the results and conclusions of their research. In addition, the course gives brief overlooks at various areas of the law, including labor and employment, international, health, education, immigration and naturalization, and military.
