What is the EJA Supplemental Grant?

EJA recognizes that many law students are called to serve the public interest, but are unable, financially, to heed this calling because of the low (or no) pay provided by non-profit organizations. This public interest grant is designed to enable first and second year students to accept public interest law positions during the summer months.

Unlike the VUSL Summer Public Interest Scholarship, which is deducted from or counted against the recipient's student loan for tuition for the following year, EJA's grant provides direct cash assistance to the student during the summer to help defray living expenses, transportation costs, and other necessities.

The number of grants offered and the amount of each grant will be determined by the EJA Supplemental Grant Selection Committee, based upon the number of applications received, the need demonstrated by each applicant, and the availability of funds. Past grants have ranged from \$100 to \$1,050 per recipient. The Selection Committee will notify applicants of the Committee's decision by April 25th. (See "Duties" below for an explanation of the disbursement policy.)

Who may apply?

EJA's Supplemental Grant is available to ALL first and second year law students. Membership in EJA is NOT required. Receipt of the VUSL Summer Public Service Scholarship does NOT affect eligibility for the EJA Supplemental Grant. Students receiving externship credit or pro bono credit for their public interest work *are not eligible* for the EJA Supplemental Grant.

What do we mean by "Public Interest Employment"?

What is considered as "pro bono" work with career services counts as public interest, except for judicial clerkships. This includes all non-profit organizations, and most government agencies. Public interest law offices rely on volunteer services provided by students to alleviate their overwhelming caseloads. Because these organizations are public interest, they are most often non-profit organizations that do not have the funds

to pay for this extra labor source. In return for their work, students receive invaluable, hands-on experience in interviewing clients, representing clients in different areas of law, and developing extensive research and writing skills.
